Changes

The plan to expand the portfolio of oral health care services has already started in Spain. Five population groups are distinguished as subsidiaries of this expansion:

Changes in fees:

As in 2023, a 2.5% reduction in membership fees has been maintained due to the economic impact of COVID-19 during 2023

Information regarding promotion of the World Oral Health Day:

In 2024, activities to celebrate World Oral Health Day included the organisation of a photo competition by patients of dental clinics, as well as a press conference and a press release to the media. Likewise, a promotional video has been made about the relevance of oral health in the context of general health.

Further information (activities):

During 2024, we have once again promoted continuous face-to-face training, essentially through clinical classrooms. However, the lessons learned during the pandemic period have enabled us to develop a wide range of free, non-clinical courses, which have been very popular.

Publications:

We continue the editing of our journals: "RCOE", with a purely scientific content, and "Dentistas", with general and informative subjects addressed to professionals and people. Both are published in quarterly editions. From 2018 onwards, the RCOE magazine becomes a digital format, maintaining the Dentistas magazine which increases to 6 issues per year. In 2024, "Ilustred Guides", a dentist-oriented supplement with up-to-date information on various current issues for dentists have been developed.

In addition, 2 White Papers have been published in 2024: one on the rational use of antibiotics in dentistry, and another on radiology in dentistry.

Campaigns:

In 2024, 3 important health education campaigns have been developed: oral health and sport, oral health and disability and oral cancer. A workshop on oral hygiene was also held for the general public and influencers.
