ERO-FDI-Survey on Young Dentists' Workplace and Employment

Dear colleagues,

Recently, however, we have seen a noticeable change in the structure of our profession, driven by the increasing influence of private investors or private equity in the healthcare sector. This development raises important questions about the long-term impact on the scope, delivery and quality of dental care and the career choices of young dentists.

Your opinions and experiences are needed now more than ever to get a complete picture of the current situation and its implications for the future. By participating in this important ERO-FDI study, you will not only help to develop a clear understanding of current conditions, but also help to set and secure the course for a future-proof dental profession in Europe.

It is crucial that we understand how young dentists perceive their working environment and what factors influence their professional decisions. This will enable us to better respond to the challenges and opportunities presented by changes in the healthcare sector.

ERO-FDI Working Group Liberal Dental Practice in Europe

After a request in regard of the target group for the questionnaire and the sharing of the results, addressed by the Dutch Dental Association KNMT, Prof. Dr. Thomas G. Wolf clarified as follows:

1. The study addresses “young dentists”. Even if there is no clear definition of "young"... the information in the study shows that it should be aimed at dentists directly after their board examinations up to a maximum of 20 years of practice. Clear categorization enables a subsequent statistical analysis. However, we would appreciate to send out the study to all members of the national dental associations.
2. The results of the study will be analyzed and published once collected. We hope that numerous dentists will take part in the study, so that we can carry out analyses broken down by country and, therefore, obtain statistically reliable statements (21st June 2024).
3. **Answers by 15 August 2024:**
429 in total, 101 Slovakia, 73 Czechia, 72 Netherlands, 61 France, 27 Germany, 23 Cyprus, 16 Ukraine, 15 Latvia, 9 Austria, and other countries less.

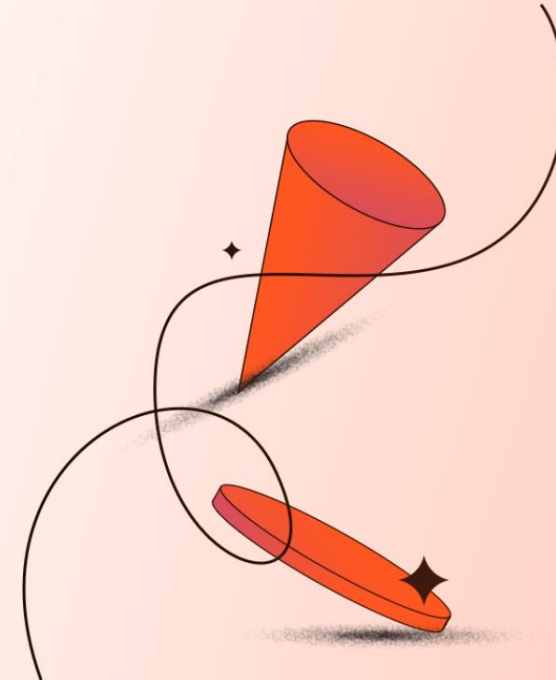

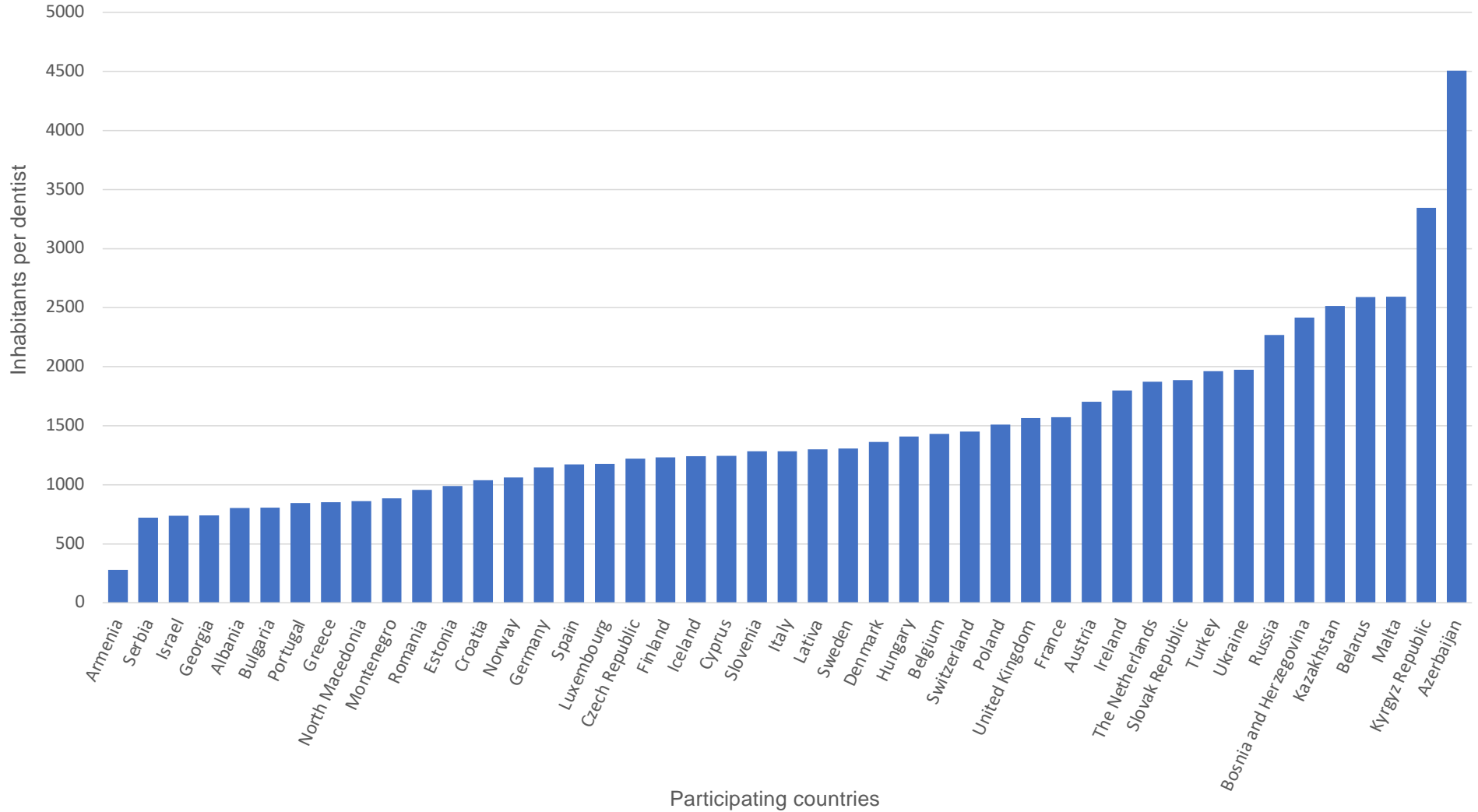
