# 36,0% of NDAs have contributed to the development of undergraduate practice based dental curriculum - How? Some examples:

- By collaborating with the ministry of health and ministry of education to establish the curricula
- A representative of the NDA / Chamber is a member of tha faculty council
- Joining Higher Education Council and Deans Council as the external body
- To consult the practiced-based dental curricula according to the proficiency level.




## The toipcs of collaboration with dental faculties regarding negotiations with authorities are:






## Have you observed any **positive changes in the partnership** of NDAs and dental faculties during the last decade?
